STANDING AGENDA ITEMS

1. Stephanie Booco called the meeting to order. A quorum was not met so a motion to approve the May 9, 2022 TAC meeting minutes was unable to be made.

DISCUSSION/DECISIONS

1. Laurie Stolen and Jessica Plummer discussed the results of the applications for the 2022 Impact Fund grant program and the review process. The Larimer County BoCC approved the 2022 Impact Fund grant recommendations as presented to the BHPC on 8/22/22 and a few grants have even already been fully signed and executed. The BoCC also approved a \$2.8 million annual allocation increase for 2023.
2. Jessica Plummer shared this [presentation](#) regarding Impact Fund Grant Program applicant and reviewer feedback.

3. Jennifer Wolfe-Kimbell shared an update on the [BHS facility](#). In July, the Larimer County Board of County Commissioners approved the recommendation to name the campus “Larimer County Behavioral Health Services at Longview” and brand each building by the service type provided - Acute Care, Adolescent Care, etc.
4. Laurie Stolen discussed the application period for BHS advisory groups which is currently open. There will be multiple seats available for each advisory group with 3 year terms beginning in December and applications are currently being accepted [here](#) through 9/29/22.

The next meeting is a combined BHPC, TAC, and CAC meeting scheduled for December 5, 2022 from 8 a.m. - 10 a.m. and will be held in-person at 200 W. Oak St. Fort Collins CO 80521.
