BOARD OF ADJUSTMENT MINUTES

The regular meeting of the Larimer County Board of Adjustment was held in the County Board Hearing Room in the Larimer County Administrative Services building, Fort Collins, Colorado and virtually via Zoom at 6:00 p.m., April 23, 2024, at which time the following business was transacted.

Board Members Present: Carol Cochrane, Lee Taylor, Philip San Filippo, Lauren Light, and David Leighton

Staff Present: Samantha Lasher (Staff Liaison), Samantha Mott, Laura Culleton, and Jacy McNulty (County Planners), and Christine Luckasen (Assistant County Attorney)

Minutes: Philip San Filippo moved and Lauren Light seconded the Motion to approve the March 26, 2024 Minutes of the Larimer County Board of Adjustment as presented. Board members Carol Cochrane, Lee Taylor, Philip San Filippo, Lauren Light, and David Leighton voted in favor of the Motion. The Minutes were unanimously approved.

The following application was approved by consent:

Request: The Application of Eugene Martin and Genco Construction LLC, requesting a variance was presented to the Board. The Application requested a setback variance to allow an existing 31.3' x 19.3' trash enclosure to be located 7 feet from the nearest edge of right-of-way where 25 feet is required.

Action: There were no requests from the public, the Board, or Staff to have a full hearing on this request and therefore it remained on the Consent Agenda. Lee Taylor moved and Philip San Filippo seconded the Motion to approve the Application with the following conditions:

1. Failure to comply with any conditions of the variance approval may result in reconsideration of the use and possible revocation of the approval by the Board of Adjustment.

2. This variance is applicable only to the trash enclosure. All future buildings or additions must be compliant with the setback requirements in the Larimer County Land Use Code or receive approval for separate variances. All future buildings or additions must go through the proper Larimer County review and permit process prior to construction.

3. The required as-built permitting for the trash enclosure, as identified within the code compliance research, must be completed within 90 days of the variance approval.

Board members Carol Cochrane, Lee Taylor, Philip San Filippo, Lauren Light, and David Leighton voted in favor of the Motion. The Application was approved with conditions.
