1. Resolution Imposing a Temporary Moratorium on Processing 1041 Permit Applications

DESCRIPTION: A temporary moratorium on processing applications will provide reasonable time to revise County Land Use Code 1041 regulations for designated areas and activities of state interest to implement the Comprehensive Plan and address potential broad impacts on the health, safety, and welfare of residents of Larimer County.

Adoption of the Resolution would mean the Temporary Moratorium on Processing 1041 Permit Applications would be effective immediately for all of Larimer County and will expire on April 15, 2021 unless sooner repealed or extended by further resolution of the Board. On April 13 at 3:30 p.m., the Board of County Commissioners will hold a hearing to allow public comments on the merits of the temporary moratorium imposed by the resolution and determine whether the moratorium should be terminated, extended, or otherwise amended.

2. Resolution Imposing a Temporary Moratorium on Processing Oil and Gas Development Applications

DESCRIPTION: A temporary moratorium on accepting oil and gas development applications will provide reasonable time to revise Larimer County's oil and gas regulations in recognition of recently adopted state rules to implement SB 19-181 and so the County's regulations may address potential broad impacts on the health, safety, and welfare of residents of Larimer County.

Adoption of the Resolution would mean the Temporary Moratorium on Processing Oil and Gas Applications would be effective immediately for all of Larimer County and will expire on April 15, 2021 unless sooner repealed or extended by further resolution of the Board.
