3. Dakota Ridge Funding Partnership and Conservation Easement

DESCRIPTION: The project is a partnership between the City of Loveland, Larimer County Natural Resources (funding partnership in the amount of \$316,000), a GOCO grant (funding partnership in the amount of \$830,000) and a private donation (funding partnership for \$300,000). The property is adjacent to the Skyline Natural Area, one-half mile east of the Devil's Backbone Open Space and approximately 1 mile south of Prairie Ridge Natural Area.

The 245-acre project would be a fee-simple purchase allowing for public access including approximately two miles of trails and a building envelope for a neighborhood park and trailhead at the north end of the property.

Upon the City of Loveland's fee acquisition of both parcels, the entire 245 acres will be placed under one GOCO conservation easement which will be co-held by Colorado Open Lands and Larimer County. Closing is scheduled for June 25, 2021.

MOTION: I move to approve the funding partnership with the City of Loveland Open Lands and Trails Division in the amount of \$316,000.00, as recommended by the Open Lands Advisory Board at its May 27th meeting.
