Hermit Park improvements expand access, advance sustainability

Larimer County Department of Natural Resources completed several accessibility and sustainability improvements at Hermit Park Open Space in the first quarter of 2026, enhancing both visitor access and operational efficiency.

The office building was upgraded with ADA-compliant features, including new accessible parking, a concrete sidewalk, an access ramp, and an improved entry door, creating a more welcoming and functional space for all visitors.

At the group pavilion, staff replaced an aging diesel generator with a solar energy system, supporting a transition to cleaner, more sustainable operations.

These improvements reflect the Department's ongoing commitment to incorporating accessibility and sustainability into capital projects, helping ensure that public spaces remain inclusive, resilient, and aligned with long-term stewardship goals.





Rangers prioritize education, positive visitor interactions in 2025

In 2025, LCDNR Rangers and Aquatic Nuisance Species (ANS) teams continued prioritizing education, safety, and positive visitor experiences across our parks and open spaces.

Staff engaged in 27,577 public interactions, with 79% focused on education—helping visitors understand regulations, safety practices, and how to responsibly enjoy shared spaces. Enforcement remained a small but necessary part of this work, with just 1 in every 47 contacts resulting in a citation. This commitment is backed by ongoing training, including 2,339 hours for full-commission rangers and more than 5,500 hours for limited-commission staff. Rangers also responded to 82 water rescues, reinforcing their critical role in keeping the public safe.

ANS teams conducted 56,777 inspections and 1,242 decontaminations, successfully intercepting seven mussel-contaminated boats and protecting Larimer County's waterways through proactive prevention and public education.

Land stewardship manager earns regional award, brings decades of experience



The LCDNR Land Stewardship Program manages vegetation across county open spaces and Bureau of Reclamation reservoirs through integrated weed management, restoration projects, and noxious weed compliance and outreach.

In 2026, Kelly Pruitt joined as the Land Stewardship Program Manager, bringing 30 years of experience in vegetation management to Larimer County.

Recently named the Western Society of Weed Science 2026 Weed Manager of the Year, Kelly combines technical expertise in vegetation management with strong partnership-building skills. Her experience working with landowners and the public will help enhance the county's natural resources.

Kelly steps into this role following Casey Cisneros, who led the program for nearly 20 years and is now pursuing ecological consulting work. The Department is grateful for Casey's long-standing leadership and contributions to land stewardship in Larimer County.



Small grants program awards \$24,711 to support community projects

Larimer County Natural Resources awarded \$24,711 in 2026 Small Grants for Community Partnering funds to support seven community and neighborhood projects that connect people to the land. The selected projects reflect a range of local efforts focused on education, stewardship, and improving access to nature across Larimer County.

Since 1998, the program has reinvested a portion of the Help Preserve Open Spaces sales tax directly into the community, supporting 253 projects with a total of \$470,700 awarded to date. Funding is available to nonprofits, community organizations, homeowner associations, and K-12 schools for outdoor, community-based initiatives.

The Small Grants program supports projects that enhance natural landscapes, expand environmental education, improve access to nature, support local agriculture, and advance research on Larimer County's open spaces.

Financial Summary

The Department of Natural Resources has five primary revenue sources including Colorado Lottery proceeds, the Help Preserve Open Spaces sales tax, user fees on open spaces, and reservoir parks, and the Weed District property tax.
